This posting is for the Ventura County Information Technology Services Department; vacancy location is Ventura and may require travel throughout Ventura County and neighboring counties.

POSITION INFORMATION

Under direction (II), or under general direction (III) the Telecommunications Network Specialist (TN Spec) for this assignment assembles, installs, maintains, modifies and/or repairs electronic equipment, two-way radios and/or point to point microwave equipment; performing related duties as required.

The TN Spec II requires journey level proficiency in the full range of activities (system and equipment installation, modification, maintenance and repair) for electronic equipment, two-way radios and/or point to point microwave.

The TN Spec III is the advanced journey level in the series and the incumbents serve as the technical resources in the assigned specialty providing functional supervision over assigned system activities and, as needed, lead the work of others in field assignments and/or in department activities.

For the current vacancy the ideal candidate will possess advanced knowledge, skills and abilities demonstrated by recent experience in electronics, two-way radio and point to point microwave technologies and collecting and analyzing data and electronic test information to support two-way radio and microwave. The successful candidates will demonstrate professionalism while in the company of coworkers, vendors and customers, be able to communicate effectively with telecommunications vendors, respond to customer inquiries and use an on-line service management system. Possession of computer skills needed to write reports will include proficiency at the intermediate level in Word, Excel, Visio and Radio Propagation Analysis software.

- Installs, services and repairs two-way radios, electronic and microwave equipment both in the field and in the shop.
- Operates and monitors two-way radio, electronic and microwave equipment; (e.g.
 measures frequencies, modulation and power output of radio, microwave and digital
 circuitry; adjusts transmitters and receivers for maximum efficiency; maintains
 battery banks and related ancillary equipment) to ensure compliance with applicable
 regulations.

- Uses inventory systems to support asset management, billing systems, parts/materials listings, and equipment performance monitoring.

- Other related duties as required.

At the (III) level additional duties may include:

- Assigning, reviewing and directing the work of other Telecommunications Network Specialists engaged in construction, installation, modification, repair and maintenance of telecommunications equipment and systems.
- Training others through use of On-the-Job (OTJ) training guidance to enhance knowledge and skills sets.
- Directing responses to service requests, incidents and problems in a service management system accurately documenting labor hours and inventory for billing and performance monitoring.

APPLICATION EVALUATION - qualifying: All applications will be reviewed to determine whether or not the stated requirements are met. Those individuals meeting the stated requirements will be invited to continue through the screening and selection process.

ORAL EXAMINATION - 100%: A job-related oral examination will be conducted to evaluate and compare participating candidates' knowledge, skills, and abilities in relation to those factors which job analysis has determined to be essential for successful performance of the job. Candidates must earn a score of seventy percent (70%) or higher to qualify for placement on the eligible list.

NOTE: If there are three (3) or fewer qualified applicants, an oral examination will not be conducted. Instead, a score of seventy percent (70%) will be assigned to each application, and each applicant will be placed on the eligible list.

Candidates successfully completing the examination process may be placed on an eligible list for a period of one (1) year.
